6. The proposed order sets out that **\$500** is the amount of child support payable by the **Respondent**, in accordance with the agreement referred to in section 4(c) of this Affidavit.
7. I have completed and attached to this affidavit **Supplementary Child Support Fact Sheet A** (special expenses), and the amount set out in the proposed order for the expenses under section 7 of the Guidelines is **\$355**.
- 8b. Medical coverage is available for the children under the **Respondent's** medical insurance plan.
9. There is no order of any court in force dealing with support of the children.
10. Attached as Exhibit **A** is the written agreement that deals with the support of the children.
