45′	<ul> <li>Read, Talk and Write</li> <li>Students work in pairs. Time	Tasks	Expected Outcome	Resources
	<ul> <li>Encourage students to take brief notes as they read, and not to copy everything!</li> <li>Have students close their PLS booklets to do Step 2, questions and answers</li> <li>When students have completed their question and answer chart, then they may look in their booklets to check their answers</li> <li>Have students close their PLS booklets when they do the writing. They may only refer to the information in their question and answer charts</li> </ul>	Identify steps on what to do when making a complaint Write 1 or 2 connected paragraphs to relate a simple procedure about how to make a complaint	Consumer Law, p. 4-5.
20'	<ul> <li>Who is speaking?</li> <li>Students can work individually or in pairs to complete the task</li> <li>Go over answers as a class and discuss</li> <li>Ask students if they know additional expressions, requests or questions related to making a complaint or returning an item and write students' contributions on the board</li> <li>In small groups, students practice the phrases in role plays about returning an item and making complaints</li> <li>Groups can perform their role plays in front of the class or teachers can wrap up this activity with a theatre sports approach (two students from different groups come to the front of the class, the teacher reads them a situation, and the two students ad lib the scene)</li> </ul>	Make requests or complaints with details and reasons and use appropriate level of politeness. Respond to requests or complaints with details and reasons and use appropriate level of politeness	PLS Worksheet: Who is speaking?

50'	<ul> <li>Find out more</li> <li>Students pair up and each pair chooses one website</li> <li>Put a time limit on the research time</li> <li>Encourage students to practice their note taking strategies</li> <li>Each student should take his or her own notes</li> <li>After the allotted time for research, partners share with each other their understanding of the information from their website</li> <li>Mix the pairs up</li> <li>In the new pairings, one student reads www.consumerinformationbc.ca and the other reads www.clicklaw.bc.ca</li> <li>Students tell their partners what they learned from their website</li> <li>Debrief as a class</li> </ul>	Get information from moderately complex business/ service text Get more information about complaints and how to file a complaint	PLS Worksheet: Find out More! 

- 1. You can make a complaint at a store if the product is not <u>a good standard or value</u>.
- It's important to know the <u>rules</u> of the store before you purchase something from the store.
- 3. You can ask the store to <u>return your</u> money back to you if you are not happy with the product.
- 4. It is your <u>duty or obligation</u> to check instructions and learn how to use a product in order to care for it.
- 5. If there are problems with the <u>item</u> you buy, the store should give you a new one.
- You can make a <u>statement about a product</u> by talking to someone, calling or writing a letter to Consumer Protection BC or the Better Business Bureau.
- 7. Be sure to keep <u>records of what you bought</u> in case you need to return an item.
- You should also collect copies of any documents, for example, some items come with a <u>contract to fix or repair the item</u> if it breaks.


